This is a courtesy notice of Ad Valorem taxes due. This tax notice is for Real/Personal Property located in Bibb County, Alabama. Real property is land and any permanent structure on your property. Business Personal Property is movable property associated with the operation of a business. If you own BUSINESS PERSONAL PROPERTY, the Code of Alabama, Sections 40-5-13 and 40-5-19, states that no Real Property payments will be accepted until ALL Business Personal Property is paid. **Taxes are due October 1 and become delinquent after December 31.** It is your responsibility to ensure payment of taxes. If you no longer own this property, or if you have questions, please notify the Tax Assessor/Collector's Office at **205-926-3105**. If your mortgage company is expected to make payment, we suggest YOU confirm receipt of taxes before January 1.

Property Owners in the State of Alabama are entitled to certain exemptions that may reduce the amount of taxes owed. There is available a "regular" homestead exemption for taxpayers who own and occupy their home as their primary residence. **If you are 65 years of age or older, disabled, or blind, additional exemptions are available.** There is also a "current use" exemption available for agricultural purposes. **Please note that all exemptions applied for this year, after approval, will be effective for the next tax year and will not affect this tax bill.** It is the responsibility of the property owner to notify the Tax Assessor/Collector's Office of any changes.
